The Assembly of First Nations (AFN) is a national advocacy organization that works to advance the collective aspirations of First Nations individuals and communities across Canada on matters of national or international nature and concern.

Canada is grappling with crises in housing, labour force productivity and participation, climate change and wildfires, strained health systems, surging public debts, and debt service costs. These crises mirror those experienced by First Nations due to underfunding, neglect, and failed legal obligations.

First Nations have long called for redress on the housing crises in their communities. They have called for access to education, skills training, and digital connectivity infrastructure to participate in the modern, global economy. They have called for all-season roads to access to the physical economy, affordable goods, construction materials, and support for emergency management and public safety.

First Nations have sought safe drinking water, the return of lands, and the right to care for their children. Canada's failure to meet these needs resulted in accelerating legal proceeding and settlement costs. Litigation is the worst-case scenario. It exudes broken promises and blatant human, Inherent, Treaty, and Constitutional rights violations.

The Federal Budget must reflect true Economic Reconciliation.

Economic Reconciliation is not achieved by simply including First Nations in procurement strategies and revenue-sharing agreements. It must be rooted in respect for First Nations' jurisdiction over their lands, territories, and resources and seek to address policies that continue to legitimize an economic system built on the structural dispossession of First Nations from their lands and waters.

The *United Nations Declaration on the Rights of Indigenous Peoples Act* (UNDA) committed Canada to take "necessary steps" and "effective measures" to meet the objectives of the UN Declaration. These include, at minimum, immediate dedicated investments for implementing UNDA Action Plan Measures (APMs).

Partnership and decisive investment is needed to close the socioeconomic and infrastructure gaps between First Nations and Canada so that everyone may prosper.
